The Warehouse Material Handler is responsible for maintaining materials, supplies, and tools stored in Coastal Electric Cooperative's warehouse. This position supports both in-house crews and contractors by ensuring efficient receipt, storage, and distribution of materials.

Essential Duties and Responsibilities

- Receive and inspect incoming materials from suppliers.
- Assist in-house crews and contractors in compiling materials for work orders.
- Relocate and stage materials from storage areas to designated pickup locations.
- Participate in material inventory counts and assist in generating weekly ordering lists for the purchasing agent.
- Operate a forklift, pallet lift, and other warehouse equipment safely and efficiently.
- Maintain a clean, organized, and safe warehouse facility.
- Ensure outgoing packages are prepared and picked up by the designated shipping company.
- Perform other job-related duties as assigned by management.
